The Zambia Accountability Programme (ZAP) is an innovative five-year 25.5 million GBP DFID-funded programme managed by the British Council. ZAP seeks to achieve the more equitable allocation and management of public goods and services. The programme is also designed to encourage and support more effective collaboration among local communities, elected leaders, government officials, civil society, learners, schools, and the private sector to positively influence the delivery of public goods and services. The Programme will be delivered, in part, through selected Grant Recipients.

ZAP is seeking applications from qualified International Non-Governmental Organisations (INGOs), national Non-Governmental Organisations (NGOs), Community Based Organisations (CBOs), and non-discriminatory Faith Based Organisations (FBOs) to implement a programme entitled **“Improved Accountability in Service Delivery in the Education Sector”** aimed at raising public awareness of development issues and promoting governance and accountability in the education sector in Central, Southern and Western Provinces Zambia.

Subject to the availability of funds, ZAP intends to provide approximately £1 Million in total for this activity to be implemented over a two and half year period. ZAP reserves the right to fund any or none of the applications submitted. Although it is planned to make an award of one award under this RFA, ZAP in its discretion may make awards to more than one organization or no award. The successful applicant will be responsible for ensuring achievement of the programme objectives.
